**ARTICLES OF INCORPORATION
OF
LAW OFFICE OF MARY J. HOFTIEZER, P.A.**

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Law Office of Mary J. Hoftiezer, P.A..

ARTICLE II

The street address of the principal office of the Corporation is: 31 North Hyer Avenue, Orlando, Florida 32801.

ARTICLE III

The specific purpose for which the Corporation is organized is:

- A. To engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney, duly licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees and agents of the corporation who are duly licensed under the laws of the State of Florida to practice law.
- B. To invest the funds of this corporation in real estate, mortgages, stocks, bonds or any other type of investment, and to own real and personal property necessary for the rendering of such professional services.
- C. To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objectives of the corporation enumerated in these Articles of Incorporation or any amendment thereof, and to do any act necessary or incidental to the protection and benefit of the corporation; and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment or furtherance of such purposes or objectives of the corporation.
- D. It is intended that this corporation may conduct and transact business lawfully authorized and not prohibited by Chapter 607 and Chapter 621, Florida Statutes, as the same may be from time to time amended.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ten thousand (10,000), all of which shall be Common Shares.

ARTICLE V

The initial street address of the Corporation's registered office is: 31 North Hyer Avenue, Orlando, Florida, 32801. The initial registered agent for the Corporation at that address is: Lisa Franchina.

ARTICLE VI

The initial board of directors shall consist of one member. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The name and address of the person who will serve on the initial board of directors is:





The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


