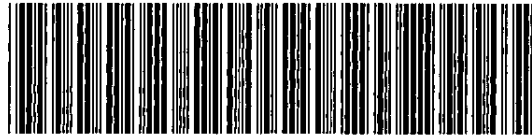

The undersigned, the authorized representative of the shareholder of the Company formed under Chapter 607, Florida Statutes (2002), adopts the following Articles of Organization for such Company ("Company"):

ARTICLE I

Name

The name of the Company is AUTOMOTIVE SERVICES, MAINTENANCE AND TRACTOR REPAIR OF PENSACOLA, INC. The new company has been given the Federal Tax Identification Number of 37-1565783 by The Internal Revenue Service as of the date of this incorporation.

ARTICLE II

Place

The principle place of business is at 1414 West Government Street, Pensacola, Escambia County, Florida, 32501.

ARTICLE III

Purpose

The Purpose of the Company is to perform, for profit and to the public, the maintenance and repair of passenger automobiles, light duty trucks, and semi tractors and trailers.

ARTICLE IV

Shares of Stock

The Company shall authorize and issue one-thousand (1,000) shares of common stock. This is the only class of stock; all holders of shares have voting rights. At the time of incorporation, the only shareholder is Toby J. Teachey, who currently resides at 10137 Bowman Avenue, Pensacola, Florida, 32534. Toby J. Teachey has been issued 600 share of common stock.

No other persons or entities have been issued any shares. Shares may be bought or sold to other persons or entities at a cost of no less than \$100.00 per share.

ARTICLE V

Officers and Directors

The remaining shareholder or shareholders of the Company may continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy, or the occurrence of any other event which terminates the continued ownership rights of a shareholder in the Company. At the date of incorporation, Toby Teachey is the only officer of the Company.

ARTICLE VI
