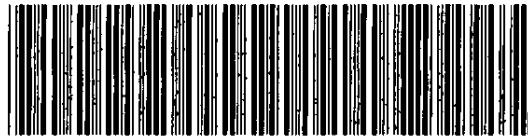

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, does hereby form a corporation under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of the corporation is Mo's Custom Carpentry, Inc.

ARTICLE II

NATURE OF BUSINESS

The Corporation shall engage in the business of providing carpentry installation and painting. This corporation shall not engage in any business other than that for which it was specifically incorporated, but it shall be permitted to invest its funds in real estate, mortgages, stocks, bonds or any other type of investment, and shall be permitted to own any real or personal property necessary in the rendering of its business and services.
