**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

- (1) Name. The name of this Corporation is **KC Invention Holdings, Inc.**
- (2) Amendment. Article I of the Articles of Incorporation of the Corporation is hereby amended and replaced with the following provision:

ARTICLE I. NAME AND PRINCIPAL OFFICE
