1. The name of the Corporation is SANIBEL ISLAND CINEMA (the ACorporation®).
2. The Certificate of Incorporation is amended in the following respect:

Article I is amended to read in its entirety as follows:

The name of the corporation shall be TITAN CINEMA, INC.

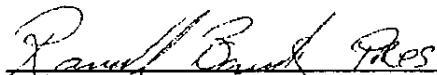
