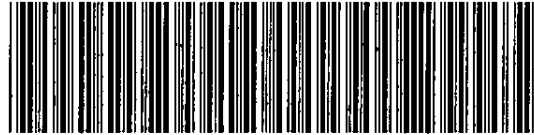

ARTICLES OF INCORPORATION

OF

ARTICLE I.

NAME

The name of this corporation is St. Pete Powersports, Inc.
