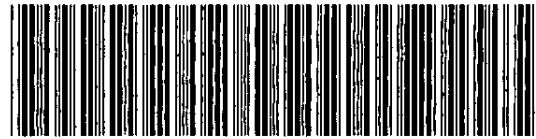

Articles of IncorporationofArmellini Examination & Global Inspection Services, Inc.

Article 1 - Name. The name of the corporation shall be Armellini Examination & Global Inspection Services, Inc. The principal place of business/mailling address is: 3446 Armellini Avenue, Palm City, FL 34990.

Article 2 - Duration. This corporation shall have perpetual existence, commencing on the date of the filing of these Articles of Incorporation with the Department of State, State of Florida.

Article 3 - Purpose. This corporation is organized for the purpose of purchasing and operating X-Ray equipment and explosive detection devises to examine airline cargo which is to be transported on commercial, passenger aircraft so as to detect any explosive devises

The corporation is empowered to rent, lease, construct or otherwise obtain facilities, buildings, warehouses or offices in support of the above enumerated objectives. In so doing, the corporation may borrow monies, execute promissory notes or mortgages, and generally to do whatever is necessary to raise the necessary capital with which to build or lease required facilities. This corporation shall be empowered to transact any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as it now may exist, or may later be amended.

Article 4 - Stock. The corporation is authorized to issue 10,000 shares of no par value common stock, hereinafter designated as the "common shares".

Article 5 - Pre-Emptive Rights. Every shareholder, upon the sale of any stock of this corporation for cash, shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

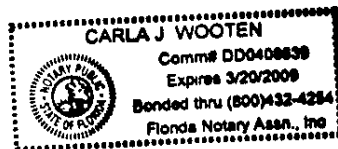
