Pursuant to the Florida Business Corporation Act, Chapter 607, Florida Statutes, the undersigned incorporator of Initrode Electric, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I NAME AND ADDRESS

The name of the Corporation is Initrode Electric, Inc., the Corporation's initial principal office and mailing address is 107 South Willow Avenue, Tampa, FL 33606.

ARTICLE II **BUSINESS AND ACTIVITIES**
