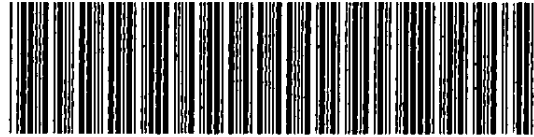



5. INCORPORATOR. The name and street address of the incorporator is Scott A. Stoothoff, 2566 Hillview Street, Sarasota, Florida 34239.


