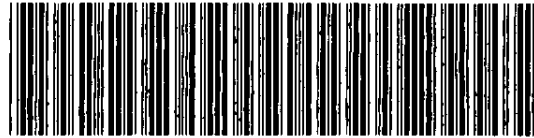

The name of this corporation is Worldwide Consulting and Advisory Group, Inc.

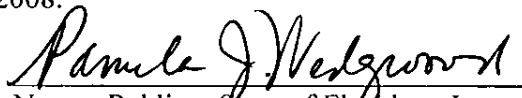

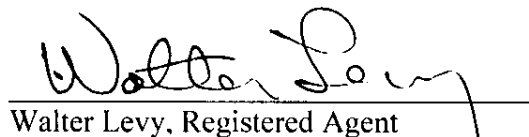
