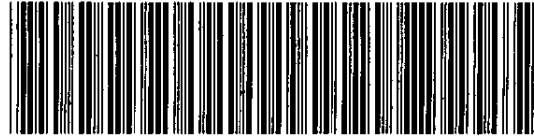

ARTICLES OF INCORPORATION OF
HIDDEN RANCH ESTATES, INC.

ARTICLE I

The name of this corporation is Hidden Ranch Estates, Inc..

ARTICLE II

The purpose or purposes for which this corporation is organized is for the purpose of transacting any and all lawful business.

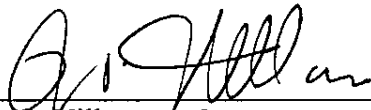
