The undersigned, for the purpose of forming a for-profit Corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

**Article I
Name**

The name of the Corporation shall be Dreams For Destiny, Inc., (hereinafter called the "Corporation").

**Article II
Principal Office and Mailing Address**

The principal office and mailing address of the Corporation is 4059 Shannon Brown Drive, Orlando, Florida 32808.

**Article III
Purpose**

The Corporation is a for-profit organization, organized for the purpose of engaging in lawful act or activity for which for profit Corporations may be organized, so far as is or may be permitted by laws of the State of Florida. The specific purpose of the Corporation is to provide everyday use products, printed material, gifts and baskets, hair salon products and services ordered or requested via Internet, mail or telephonic request through courier, in-person, and mail and freight delivery. Further, to own and operate salons for licensed cosmetologists, barbers, pedicurists and nail technicians to service customers and sell products and services and to conduct training seminars, workshops and shows that will empower and equip hair and marketing professionals.

The Aggregate number of shares that the Corporation is authorized to issue is 100. Such shares shall be a single class and shall be a per value of \$1.00 per share.

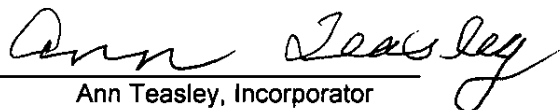
