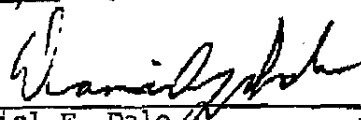
ARTICLE IX. AMENDMENT TO ARTICLES OF INCORPORATION
