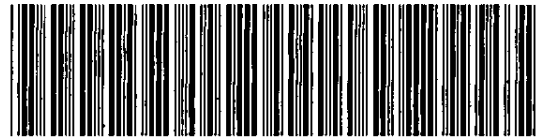

**ARTICLES OF INCORPORATION
OF**

JOHN'S PULL & SAVE OF PALATKA, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is **John's Pull & Save of Palatka, Inc.**

ARTICLE II

Principal Office

The mailing address of the corporation is P.O. Box 1984, Bunnell, Florida 32110 and the principal address of the corporation is 3725 South U.S. Highway 1, Bunnell, Florida 32110.

ARTICLE III

Duration

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

ARTICLE IV

Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V

Capital stock

(a) **Authorized Capital.** The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share.
