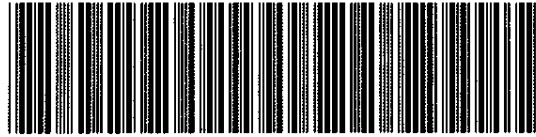

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Business Corporation Act, Chapter 607, Florida Statutes.

**ARTICLE I**

The name of the corporation is "Florida Consumer Alliance, Inc." The principal place of business is: 218 South Monroe Street, Tallahassee, Florida 32301.

**ARTICLE II**

This corporation shall have perpetual existence.

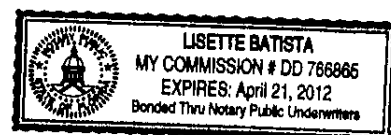


