ARTICLES OF INCORPORATION OF SPRINKLER FEED INCORPORATED

DIVISION OF PH 2: 57

ARTICLE I Name and Address

The name of this corporation is SPRINKLER FEED INCORPORATED. The mailing address and principal place of business for the corporation is: 509 Nantuckett Drive, Temple Terrace, Florida, 33617.

ARTICLE II Purposes and Powers

The general purposes for which the corporation is organized are:

- 1. To engage in the business of acquiring legal title to and licensing the use of patents, trademarks, copyrights, and other forms of intellectual property;
- 2. (ii) any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock of the corporation of any class or classes, or to which is attached or pertinent any warrant or warrants or other instrument or instruments conferring on the holder the right to subscribe for or purchase from the corporation any shares of its stock of any class or classes.
