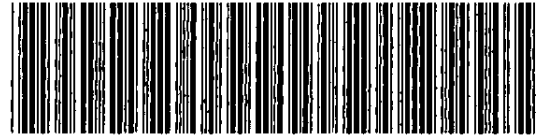

The undersigned incorporator, for the purpose of forming a professional association under the Professional Service Corporation and Limited Liability Company Act (the "Act"), hereby adopts the following articles of incorporation.

**ARTICLE I**

Name and Duration

The name of this professional association is BRIAN ROWLAND, P.A. The duration of the professional association is perpetual. The effective date upon which this professional association shall come into existence shall be the date these articles are filed by the Secretary of State.

**ARTICLE II**

Principal Office and Mailing Address

The address of the principal office of the professional association in the State of Florida is: 10752 Deerwood Park Boulevard South, Waterview II, Suite 100, Jacksonville, Florida 32256.

**ARTICLE III**

Corporate Purposes, Powers and Rights

The general purpose for which this professional association is organized shall be:

1. To render professional legal services to the general public, and to do all things related thereto that are customarily done by lawyers under the laws of the State of Florida, with all rights, powers and privileges granted by the Act.

2. In furtherance of its corporate purposes, the professional association shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Act.

**ARTICLE IV**

Capital Stock

The maximum number of shares of stock that this professional association is authorized to have outstanding at any one time is Ten Thousand (10,000) shares having \$.01 par value.

**ARTICLE V**  
**Shareholder Restrictions**

No person other than an individual who is duly licensed or legally authorized to render legal services in the State of Florida may own stock of this professional association. No shareholder of this professional association shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his or her stock. Any stockholder who becomes legally disqualified to render legal services shall sever all employment with and financial interest in the professional association. No shareholder shall transfer any shares of stock of the professional association, except to another individual who is eligible to be a shareholder of the professional association.

**ARTICLE VI**  
**Registered Office and Agent**

The street address of the registered office of this professional association is: 10752 Deerwood Park Boulevard South, Waterview II, Suite 100, Jacksonville, Florida 32256, and the name of the registered agent of this professional association at that address is Brian M. Rowland.

**ARTICLE VII**  
**Directors**

1. This professional association shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one (1). There shall always be an odd number of directors. The manner of selection of directors shall be as provided in the Bylaws.

2. The names and street addresses of the members of the first board of directors of this professional association, who are licensed to practice law in the State of Florida, are:

3. If any vacancy occurs in the board of directors during a term, the remaining directors, by affirmative vote of a majority thereof, may elect a director to fill the vacancy until the next annual meeting of shareholders. If there is only one director, the vacancy shall be filled by election of the shareholders who shall, without undue delay, conduct a special meeting for such purpose pursuant to the bylaws' provisions on special meetings.

## ARTICLE VIII

### Bylaws

The power to adopt, amend or repeal bylaws for the management of this professional association shall be vested in the board of directors or the shareholders, but the board of directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to the amendment or repeal by the board of directors.

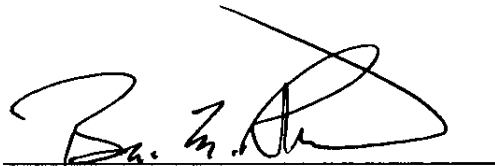
