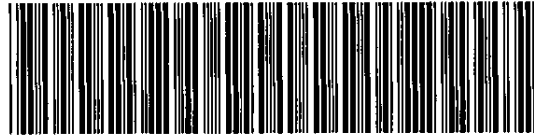

**ARTICLES OF INCORPORATION**

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. **NAME AND ADDRESS OF CORPORATION**: The name of this corporation is: **COASTAL LIFESTYLE ENTERPRISES, INC.** The mailing address of the corporation is 1601 North Central Avenue, Unit 203, Flagler Beach, Florida 32136.
2. **DURATION**: The period of its duration is perpetual.
3. **PURPOSE**: The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

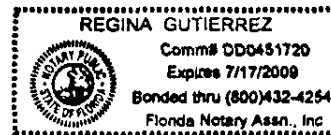
