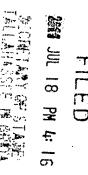

Articles of Incorporation For Safe -T- Lite Corporation

The undersigned subscriber to the Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation under the laws of the state of Florida. Pursuant to Chapter 607 and 621 Florida Statutes (F.S.).

ARTICLE I

Name

The name of this corporation shall be the: Safe-T-Lite Corporation.

ARTICLE II

Address

ARTICLE III

Purpose
