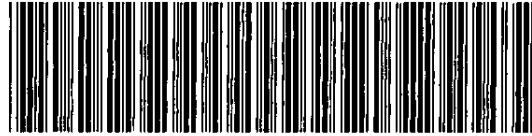

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I**

**NAME**

The name of the corporation shall be:

GET UP GRAPHICS INK, CORPORATION

Its business shall be carried on in the State of Florida, in the United States of America and elsewhere, as may be authorized by its Board of Directors.

**ARTICLE II**

**NATURE OF BUSINESS**

The general nature of the business to be transacted by the corporation shall be: Graphics design and sales, and all manner of services connected therewith.

In addition: The corporation may engage in or transact any or all activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III**

**CAPITAL STOCK**

The authorized capital stock of this corporation shall consist of One Thousand (1000) Shares of Common Stock having a par value of One Dollar (\$1.00) per share.
