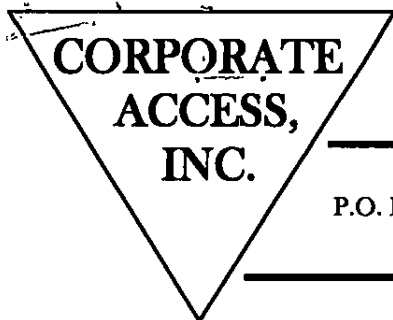

The Articles of Incorporation were filed on July 22, 2008, and assigned document number P08000069339.


