SHARES

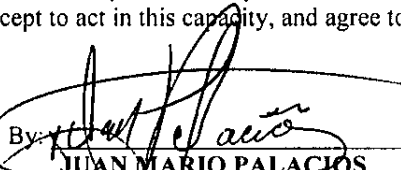
