ARTICLES OF INCORPORATION OF HOLIDAY BLUE, INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act. Chapter 607 of the Florida Statutes, hereby a dopts the following Articles of Incorporation:

ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is <u>HOLIDAY BLUE, INC.</u>, hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE VI: PREEMPTIVE RIGHTS
