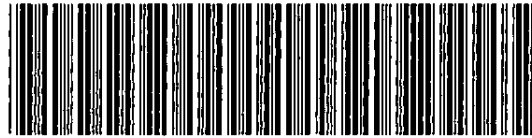



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of this corporation is SCOTT, REZNIK & ASSOCIATES, P.A.

**ARTICLE II. NATURE OF CORPORATE BUSINESS**

The corporation is limited to the practice of law by duly licensed attorneys, members of the Florida Bar as permitted under the laws of the United States of America and under the laws of the State of Florida.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock this corporation is authorized to have outstanding at any time is ONE THOUSAND, TWO HUNDRED (1,200) shares of common stock, each share having a par value of One Cent (\$.01).


These Articles of Incorporation may be amended in the manner provided by law. Every

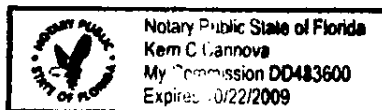
