OF

ARTICLE I - NAME

The name of the Corporation is MELISSA AMAYA, L.C.S.W., P. A.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - NATURE OF BUSINESS

(Special Purpose)

The special purpose for which this corporation is being organized shall include the practice of Licensed Clinical Social Work services as a professional Licensed Clinical Social Work corporation and to carry on services incident thereto, the practice of general clinical social work services is the sole and exclusive professional service to be rendered by this corporation. - C. To purchase the corporation assets of any other corporation and engage in the same or other charter of business.
- **D.** To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire and dispose of the shares of the capital stock or any bonds, securities, or other evidence of indebtedness, created by any other corporation of the State of Florida

or any other state or government and whole owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
