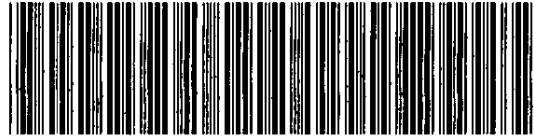

ARTICLE I: NAME

The name of this corporation is:

**FINKBEINER & ASSOCIATES, P.A.**

ARTICLE II: DURATION

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE III: PURPOSE AND AUTHORIZATION

This corporation is organized for the purpose of transacting any or all lawful business as a professional law office offering legal representation and counseling to the general public, governmental agencies and public and private corporations. The formation of this corporation is authorized by F.S. 621.05.
