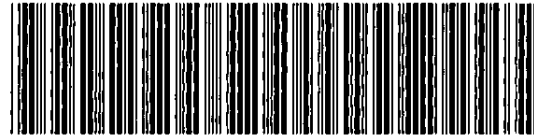

9. **Shares Without Certificates.** The shareholders or the board of directors may authorize issuance of some or all of the shares without certificates as permitted by the Act.

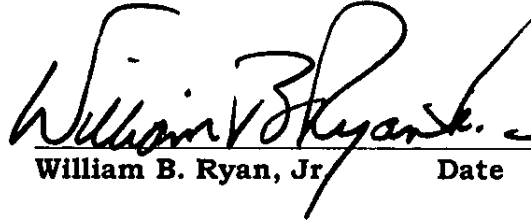
