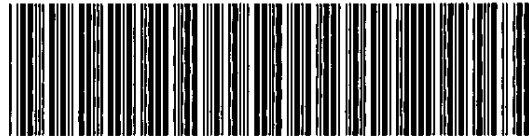

INFORMAL ACTION OF DIRECTORS



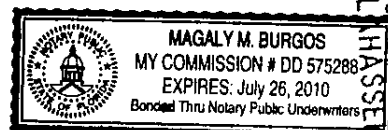
