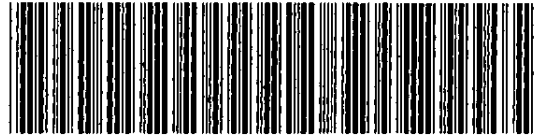

ARTICLES OF INCORPORATION
OF
INFANT SWIM TEACHER INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is INFANT SWIM TEACHER INC.

ARTICLE II - PURPOSE

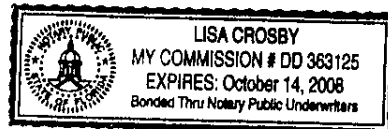
