ARTICLES OF INCORPORATION

OF

SUERO-FONTE HOLDING CORP.

We, the undersigned, for the purpose of forming a For-profit corporation in accordance with the laws of the State of Florida, acknowledge and file these Articles of Incorporation in the Office of the Secretary of State of the State of Florida.

ARTICLE I

NAME

The name of this corporation shall be SUERO-FONTE HOLDING CORP. The address of the corporation is 8433 w. Okeechobee Road, Hialeah Gardens, Fl. 33016.

ARTICLE II

PURPOSES AND POWERS

The Corporation shall have the following powers:

A. To manage, operate and administer SUERO-FONTE HOLDING CORP. (referred to herein as the "Corporation"), and to undertake the performance of, and to carry out the acts and duties incident to, the administration of the Corporation in accordance with the terms, provisions, conditions and authorizations contained in these Articles, and the Corporation's By-Laws.

B. To borrow money and issue evidences of indebtedness in furtherance of any or all of the objects of its business; to secure the same by mortgage, deed of trust, pledge or other lien.

C. To carry out the duties and obligations and receive the benefits given the Corporation.

D. To establish By-Laws and Rules and Regulations for the operation of the Corporation and to provide for the formal administration of the Corporation.

E. To contract for the management of the Corporation.

F. To acquire, own, operate, mortgage, lease, sell and trade property, whether real or personal, as may be necessary or convenient in the administration of the Corporation.

G. To sue and be sued.

J. The Corporation shall have all of the common law and statutory powers of a corporation for-profit which are not in conflict with the terms of these Articles and the law of the

State of Florida and United States, and shall have all of the powers reasonably necessary to implement the purposes of the Corporation.

ARTICLE III

EXISTENCE

The Corporation shall have perpetual existence and shall commence upon the filing of these Articles of Incorporation by the Department of State of State of Florida.

ARTICLE IV

ARTICLE V

By-Laws

The By-Laws of the Corporation shall be adopted by the initial officers. The By-Laws may be amended in accordance with the provisions thereof.

ARTICLE VI

INDEMNIFICATION

Every officer of the Corporation shall be indemnified by the Corporation against all expenses and liabilities, including counsel fees reasonably incurred by or imposed upon the officer in connection with any proceeding or any settlement thereof to which the Director or officer may be a party, or in which the Officer may become involved by reason of the Director or Officer being or having been a officer of the Corporation, whether or not a officer at the time such expenses are incurred, except in such cases wherein the officer is adjudged guilty of willful misfeasance or malfeasance in the performance of the officer's duty; provided that in the event of a settlement, the indemnification herein shall apply only when such settlement and reimbursement is in the best interest of the Corporation. The foregoing right of indemnification shall be in addition to and not exclusive of all of the rights to which such Director or


ARTICLE VII


