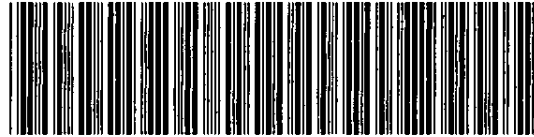

**ARTICLES OF INCORPORATION**

The undersigned, for the purposes of forming a corporation under Section 621 of the Florida Statutes, does hereby certify as follows:

**ARTICLE I**

**Corporate Name and Address**

**ARTICLE II**

**Corporate Purposes**

The Corporation is organized to engage in the practice of chiropractic services.

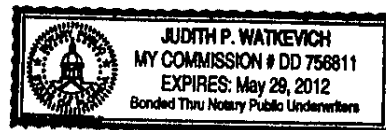


