**ARTICLES OF INCORPORATION
OF
PAR 1 Wholesale, Inc.**

We, the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to these Articles of Incorporation.

ARTICLE I

The name of the corporation shall be PAR 1 Wholesale, Inc. (the Corporation).

ARTICLE II

The Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III

Capital Stock

This Corporation is authorized to issue a maximum of ONE HUNDRED (100) shares of stock. The shares of stock authorized shall be common stock having a par value of One (\$1.00) Dollar per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

ARTICLE IV

The corporation is to have perpetual existence.

ARTICLE V

PREEMPTIVE RIGHTS

Each shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his/her prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI

RESTRICTION ON STOCK TRANSFER

If any shareholder at any time desires to sell, transfer, encumber, or otherwise dispose of his/her shares of the corporation, he shall first offer his/her shares to the Corporation and then to the shareholders.

ARTICLE VII

1244 STOCK

The shares of this corporation may be issued pursuant to the provisions of Section 1244, Title 26 of the Internal Revenue Code so that the shareholders may receive the benefits thereunder.

ADDRESS

The initial street address of the principal office of this corporation in the State of Florida is 2146 NW 73rd Terrace, Pembroke Pines, FL 33024 and the Board of Directors may, from time to time, move the principal office to any other address in Florida.

ARTICLE XI

Amendments

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by a majority of the stockholders entitled to vote thereon, unless all the Directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of the Articles of Incorporation be made. The Directors of this corporation shall have the power to make or amend the By-laws and to fix any amount to be reserved for working capital. The private property of the stockholders shall not be subject to the payment of the corporate debts in any extent whatsoever. The corporation shall have a first lien on the shares of its members and upon the dividends

due them for any indebtedness of such member of the corporation.

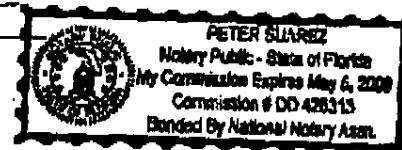
