The undersigned incorporators of these Articles of Incorporation, each a finatural person ATE competent to contract, hereby associate themselves together to form a corporation under the laws of PRIDA the State of Florida.

#### **ARTICLE I. NAME**

The name of this corporation is:

#### INTERNATIONAL SHOWCASE GALLERIES, INC.

#### ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to operate a retail sales and gallery for glass and artwork business; and to engage in every and any aspect and phase of any and every lawful business, including, but not limited to, the following activities:
