Pursuant to the provision of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Florida Flavors and Concentrates, Inc. (the "Corporation").

2. The following amendment of the Articles of Incorporation was agreed to and adopted by the sole director and all of the shareholders of the Corporation on the 10th day of September, 2013, in the manner prescribed by Section 607.1003 of the Florida Business Corporation Act:
