ARTICLES OF INCORPORATION NAPLES TANNING SALON, INC.

MA THE TOWN In compliance with the requirements of F.S. Chapter 607, the under natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE J - Name

The name of the Corporation shall be Naples Tanning Salon, Inc.
