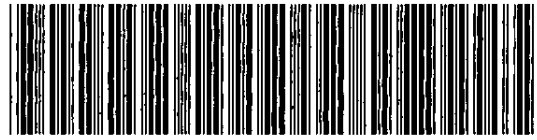

**ARTICLES OF INCORPORATION
OF

I, the undersigned hereby execute these articles for the purpose of becoming incorporated under the laws of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation for profit.

ARTICLE I

The name of this corporation is Law Office of Scott Glassman, P.A.

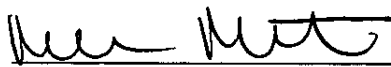
