ARTICLE I  
CORPORATE NAME

The name of the corporation is TECH BUILDERS CONSTRUCTION CORP.

DURATION

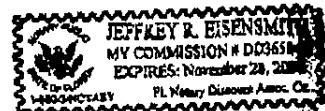
