**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is **QUIMBY INVESTMENTS, INC.** (the "Corporation").

- THIRD:** The Corporation is authorized to issue 7,500 shares of common stock, par value \$1.00 per share.

- EIGHTH:** The corporate existence of the Corporation shall commence on August 7, 2008.


