1. The Name of the professional association is: SOURCE POINT ACUPUNCTURE, P A ("Corporation").

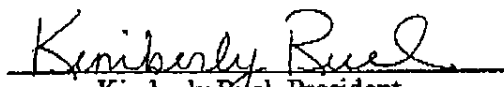
2. The date of filing of the Articles of Incorporation of the Corporation was August 13, 2008 and assigned document number P08000075585.
