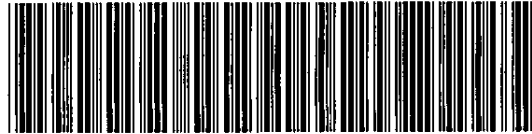

- (D). To transact any lawful business within and outside the United States of America for which corporations may be registered

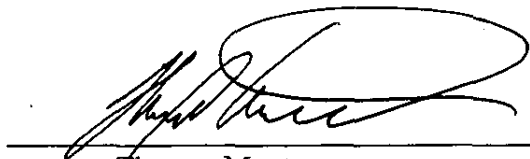

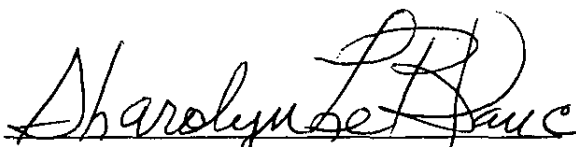
