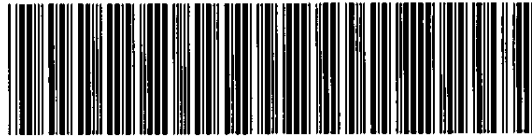

**ARTICLES OF INCORPORATION
FOR
ECONOMIC ADVISORS, INC.**

The undersigned incorporator, for the purpose of forming a corporation for profit pursuant to the laws of the State of Florida, and particularly Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation:

**ARTICLE 1
NAME**

The name of the Corporation shall be ECONOMIC ADVISORS, INC.

**ARTICLE 2
OFFICE**

The principal office of the Corporation shall be 121 N. Monroe Street, #8002, Tallahassee, Florida 32301, or at such other place as may be subsequently designated by the Board of Directors. The initial mailing address of the Corporation shall be P. O. Box 14145, Tallahassee, Florida 32317.

**ARTICLE 3
PURPOSE**

The purpose for which the Corporation is organized is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE 4
POWERS**

The Corporation shall have all of the common-law and statutory powers of a corporation for profit under the Laws of Florida, except as expressly limited or restricted by the terms of these Articles or the Bylaws, and all of the powers and duties reasonably necessary to operate the Corporation pursuant to the Bylaws, as they may be amended from time to time.

**ARTICLE 5
AUTHORIZED SHARES**

The Corporation shall be authorized to issue up to one hundred (100) shares, having a par value of One Dollar (\$1.00) per share.
