The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is Planet First Resources, Inc. and its principal office and mailing address is 10040 Brompton Drive, Tampa, FL 33626.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on the date of filing with the Florida Secretary of State.

General Nature of Business

Capital Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall
