
**ARTICLE XI

ARTICLE XII



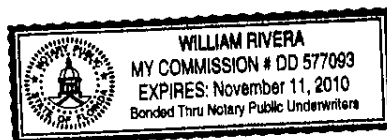
