ARTICLES OF INCORPORATION OF WTC PROPERTIES, INC.

The undersigned, acting as the Sole Incorporator of the Corporation under the <u>Florida General Corporation Act</u>, adopts the following Articles of Incorporation for such Corporation:

FIRST

The name of the Corporation is:
