**ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS**

The name of the Corporation shall be **ZACARIAS & ASSOCIATES, INC.** The principal and mailing address of the corporation shall be 27604 Cashford Circle, Suite 101D, Wesley Chapel, FL 33544.

**ARTICLE II - CAPITAL STOCK**




