

ARTICLES OF INCORPORATION

<u>ARTICLE I - NAME</u>

The name of the corporation is Innovative Business Solutions & Consultants, Inc., at 3121 Vassar Street, Melbourne, FL 32901 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
