ARTICLE 1. CORPORATE NAME

ARTICLE X. MANAGEMENT AND VOTING

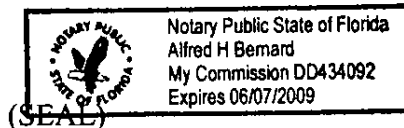
