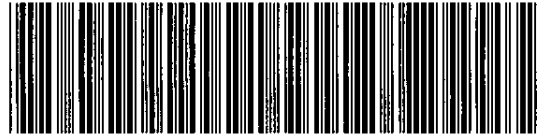

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:


A. The name of the corporation is hereby amended to read: **First Florida Insurance Network of Saint Augustine, Inc.**
