**ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Stephanie Waltbillig ID, Inc.

ARTICLE II

The street address of the principal office of the Corporation is: 1287 28th Ave N, Naples, FL 34103.

ARTICLE III

The specific purpose for which the Corporation is organized is: Interior Design and any other lawful design business.

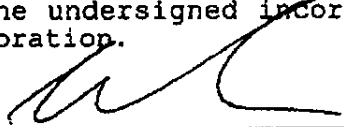

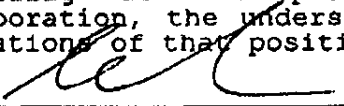
