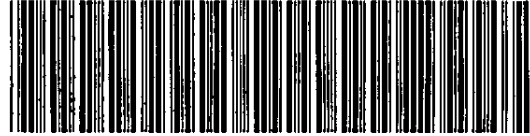

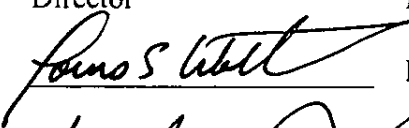

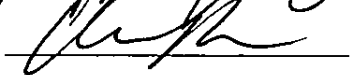

This plan of merger is submitted in compliance with section 607.1101, Florida Statutes, and in accordance with the laws of any other applicable jurisdiction of incorporation.

First: The name and jurisdiction of the surviving corporation:

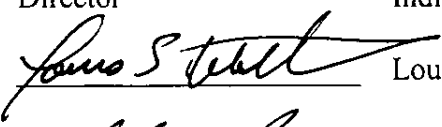

Third: The terms and conditions of the merger are as follows:

For consideration in the amount of \$10.00 and the assumption of all of the liabilities of the merging corporations, the merging entities shall be merged into HDRepair.com Corp., which shall be the surviving entity and shall continue to be known as HDRepair.com Corp. All rights, obligations, title and interest of the merging entities shall now belong to HDRepair.com Corp., including that HDRepair.com Corp. shall have the right to do business as LOVJUICE, pursuant to the franchise rights owned by the merging entity.

Fourth: Prior to the merger, Losowe Capital, Inc. was the 100% shareholder of LOVJUICE, INC., Clarissa Roxberry (50%) and Robert Roxberry (50%) were collectively the 100% shareholder of Roxberry Enterprises, Inc. and Clarissa Roxberry (51%) and Robert Roxberry (49%), collectively the "Roxberry's" were the 100% shareholders of the surviving corporation. Upon the Effective Date of the Merger, the Roxberry's shall retain a 100% interest in the surviving corporation.

HDRepair.com Corp. shall pay to each of the Roxberry's, as the 100% shareholder of Roxberry Enterprises, Inc. and Losowe Capital, Inc., the sum of \$10 in consideration of the merger of LOVJUICE, INC. and Roxberry Enterprises, Inc. into and with HDRepair.com Corp.
